Your Excellency,

We write to raise serious concerns regarding [recent Human Rights Watch research](#) revealing that UAE prison authorities are denying foreign prisoners living with HIV in some UAE prisons regular and uninterrupted access to lifesaving antiretroviral treatment. Human Rights Watch also found that prison authorities in al-Awir central prison and al-Wathba central prison have segregated detainees living with HIV from other prisoners and systematically discriminated against them.

The research, based upon interviews with former prisoners and family members of prisoners, found while foreign prisoners in one UAE prison are getting regularly tested for HIV, prison authorities are denying them HIV treatment for weeks or months on end, and that despite some prisoners' worsening health conditions, including some whose test results have displayed a dangerously low count of CD4 cells, prison authorities continue to deny them access to critical medical care and attention. One former foreign prisoner in the UAE was reportedly denied HIV treatment throughout his year-long detention in both al-Awir and al-Sadr prisons.

The segregation of prisoners living with HIV from the rest of the prison population based on their HIV status is also harmful and in violation of international guidelines and best practice for managing HIV in prisons.

As a UN member state, the UAE committed to the 2030 Agenda for Sustainable Development in 2015, and in doing so committed to ending HIV by 2030, to combating hepatitis, to promoting peaceful and inclusive societies for sustainable development, and to achieving "zero discrimination" against people living with HIV.

We are calling on you to ensure that all prisoners in UAE custody have access to appropriate HIV prevention, treatment and care, to launch an independent investigation into the denial of adequate medical care in UAE prisons and to allow independent international monitors to

enter the country and regularly monitor prison and detention facilities, including by conducting private visits with prisoners.
